### **1. Bloomsbury News**

#### **i) BLE migration to Moodle**



The BLE's licence with Blackboard expires at the end of July 2011. This deadline provided an opportunity for the Colleges to review the existing platform and consider an alternative. The BLE Steering Group, commissioned a pedagogical comparison between Blackboard 9.1 (the latest version) with Moodle, and consulted with staff and students across all five participating Colleges (Birkbeck, IOE, LSHTM, RVC and SOAS). The result was overwhelmingly in support of switching from Blackboard to Moodle as the future VLE for all Colleges. In addition, this switch will also bring some significant savings to the consortium.

Early adopter courses will be running on the Moodle platform from September 2011 followed by *all* courses by the academic year 2012-13. An additional year with Blackboard will provide sufficient time to migrate users to the new platform, including moving course material and delivering training.

A migration project website and blog have been set up to keep all Bloomsbury staff and students informed about the process. Documentation will also be available on the website.

A £12.5 million fund was announced in February that aims to help universities and colleges deliver better value for money by working together more effectively (Note 1). HEFCE and JISC now confirm the projects and partners appointed to deliver the two parts of this work: a national cloud infrastructure and supporting services.

Notes and comments scribbled by Charles Darwin on the pages and margins of his own personal library have been made available online for the first time. In total, Darwin's library amounted to 1480 books, of which 730 contain abundant research notes in their margins <http://www.biodiversitylibrary.org/collection/darwinlibrary>

### **iv) UNESCO joins iTunes U**

UNESCO has joined a host of other educational bodies in providing free content via iTunes U. The content includes: several hundred films, podcasts, and documents available in three languages (English, French and Spanish), ranging from training support materials, to policy reports and journals, and lectures, interviews and documentaries which can be downloaded for free to a computer, iPad, iPhone or iPod touch <http://www.unesco.org/new/itunes/>.

### **v) Sustaining and Embedding Innovations: Good Practice Guide**

Last year JISC produced a good practice guide to sustaining and embedding innovations based on the experience of these two programmes as well as other JISC and sector initiatives. The original guide has been updated by the author Peter Chatterton and developed into an online resource. The Record of Student Work <http://www.vads.ac.uk/collections/RCAROSW> is a rare collection, containing over 30,000 slides of student work, which dates back to the 1960s and includes early work by notable College alumni including David Hockney, Tracey Emin, Ridley Scott and Thomas Heatherwick.

**viii) CJOM - Cambridge Journals Online goes mobile**

Cambridge Journals Online host over 100 of SOAS' e-journal subscriptions; including the Bulletin of the School of Oriental & African Studies and the China Quarterly. The site is now available in a mobile version, which is designed for ease of use with smart phones (inc. iphone/pod, Blackberry and Android compatible devices).

**ix) Colonial Film: Moving Images of the British Empire**
